MESSAGE FROM YOUR BOARD

After the destruction of Hurricane Matthew in October of 2016, the Low Country was fortunate this year. This hurricane season was a severe one for Texas, Florida and the Caribbean. Fortunately, Hilton Head was spared even though the island was evacuated for four days.

As reported to you in a previous letter about Hurricane Matthew, Players Club had a lot of roof damage. Every unit had varying degrees of damage, some units had broken windows and there was extensive tree debris clean up. Clean up and repairs were expedited and the resort was reopened two weeks after the island was allowed to be re-inhabited. The final tabulation of all hurricane related costs are \$246,433 which is divided between two policies – our regular property damage policy that includes hurricane coverage and the federal flood insurance policy. Since hurricane coverage has a high deductible, the \$134,527.84 that applied to our property damage policy did not exceed the deductible amount and had to be paid out of our Reserve Fund. The \$126,905.16 that applied to the flood policy has yet to be settled. Players Club, VRI and our insurance agent are pushing hard for payment. Therefore, Players Club costs are \$137,524.87 or maybe as much as \$264,433 if the floor claim is ultimately rejected in full. However, due to a well-managed Reserve Fund, there is sufficient money to cover these costs without a special assessment.

We are pleased to report that the annual assessment for 2018 will remain the same as 2017 – studios are \$434, one bedrooms are \$498 and two bedrooms are \$553. As a reminder, there is a payment plan that all owners can take advantage of if they wish. Please call the resort at (843) 842-6640 and talk to Pamela to get specifics. Also, owners can take advantage of online banking via Smartstreet/Union Bank.

The last major piece of our multi-year improvement program will be the repaving of the rear parking lot. This is planned to be completed at the end of 2017 or early 2018, depending on the weather.

Other improvements during 2017 include: replacement of AC units (as needed), replacement of some king and twin mattresses, continued upgrading of appliances to stainless steel and adding some security and walkway lighting throughout the property.

Improvements that will be made during maintenance weeks in December include: repairing walkway cracks at both building entrances, upgrading the electrical breakers in the 300 building, re-glazing bathtubs and Jacuzzis, as needed, in both buildings and updating unit directories.

As a result of this continuous attention to maintain the quality of the resort by Pam Vernon and her staff, Players Club received the RCI SILVER CROWN status for the 2016-2017 year.

An additional change that was made in September is that owners and guests no longer have to utilize the switchboard services through Spinnaker. They can now receive inbound calls directly to their units. The telephone number for each unit is listed in the directories located in each unit.
