## MESSAGE FROM YOUR BOARD

As you know, this past Fall was a difficult time for the Southeast coast. Hurricane Matthew caused extensive damage to the area. Hilton Head, Bluffton and surrounding areas were under a mandatory evacuation for the first time in years. The damage to Hilton Head Island was widespread but not as devastating as it could have been had the storm been of greater magnitude. As it was, there was massive tree loss and cleanup, all utilities were disrupted for a period of time, and a large percentage of the buildings on the island sustained some damage, but most remained structurally sound.

Players Club seemed to fare a little better than most. We had a fair amount of roof damage, and every unit had some degree of water damage. We also had a few broken windows and lost a few trees. Pam Vernon, our General Manager, and her staff did an excellent job of locking down the property prior to the storm to minimize damage to the resort as well as returning to the property as soon as was allowed to assess the damage and to oversee the restoration. VRI, our management company, did a great job of notifying incoming guests about closures and alternate dates as well as getting the restoration company on site to remediate the damage quickly. Players Club was restored and open 2 weeks after the island was reopened. VRI is still in the process of filing all of the claims with the various insurance companies and there is no final tabulation of the cost to Players Club. However, at this point, it does not appear that there will be a need for a special assessment. VRI and the Board together have managed the financial affairs of Players Club in a very professional manner that maintains a well funded reserve account.

We had our Board meeting in February and, with the exception of lost trees, the island was back to normal. You should have no concerns about vacationing on Hilton Head Island. Also, at that Board meeting, Jim Bard was elected as a new Director. Welcome to the Board, Jim.
